PURPOSE & SCOPE

The purpose and scope of this policy is to ensure that diagnostic, preventative, and therapeutic physical health services are available to all Rocky Vista University (RVU) students.

POLICY STATEMENT

Rocky Vista University (RVU) is committed to ensuring all students have access to comprehensive physical health services that support their health, well-being, and academic success at each of its educational sites. These services include diagnostic, preventive, and therapeutic care, provided through a variety of resources and partnerships tailored to meet the diverse needs of RVU students.

All students are required to obtain health insurance prior to matriculation and to maintain their individual health insurance throughout their enrollment at the University. Students on RVU sponsored international experiences or rotations must show proof of travelers' insurance which covers emergency care and health care in foreign countries. The RVU Student Handbook contains information regarding student health insurance, including processes for waiving student health insurance with documentation of alternative equivalent coverage. student health insurance with documentation of alternative equivalent coverage.

Students on clinical rotations away from the main campuses who are in need of physical health services should follow site-specific guidelines for accessing health care as stated in the Clinical Rotation Manual.
