Subject: Initial Accreditation

Dear Dr. Atkins:

The Council on Accreditation of Nurse Anesthesia Educational Programs (COA) is pleased that accreditation has been awarded to the nurse anesthesia program at Rocky Vista University, Englewood, CO, effective January 22, 2025. This signifies that all of the procedural steps have been successfully completed up to this point in time. This decision recognizes that the program will provide a graduate level curriculum leading to the award of a Doctor of Nurse Anesthesia Practice. A certificate designating this accreditation will be mailed under separate cover. It is the COA's understanding that the effective starting date of the program is May 2025. Notification must be provided to the COA if the effective date is different or changes.

As the CRNA program director of an accredited nurse anesthesia program, you will be required to complete annual reports each year. The annual report is web-based and electronically transmitted to the COA. Additionally, two (2) years after the start of the program's first class of students, the program is to submit confidential and anonymous faculty and student evaluations of the program. Further information regarding the evaluations will be sent to you in **Fall 2026**.

A second onsite visit to the program will be conducted after five (5) years following the start of the program's first class of students. This will allow time for certification examination scores and other measures of student achievement to be assessed by the program and reviewed by an onsite review team prior to consideration for continued accreditation. Accordingly, the program will be scheduled for its next onsite visit in **Spring 2030** followed by the Council's review of the program for continued accreditation in **Fall 2030**.

Every nurse anesthesia program has a unique program code. The code for the Rocky Vista University Doctor of Nurse Anesthesia Practice Program is 523617, which eventually will be published in appropriate documents. This letter also is copied to the National Board of Certification and Recertification for Nurse Anesthetists (NBCRNA) and the American Association of Nurse Anesthesiology (AANA) as notification of the name of the program and that accreditation has been attained.

Please note, the COA appreciates the update provided on the University's submission of Title IV compliance reports to the Department of Education, submitted in response to Standard G.2

The COA requests that the program provide another update for consideration at the May 20-22, 2025 COA meeting; however, the program is no longer considered out of compliance with this Standard.
